May 9 - 10, 2026

Thank you for entering Belgian Sheepdog Club of American All Breed agility trial. This trial is being held at Omaha Sports Complex, 14706 Giles Rd, Omaha, NE 68138. **ABSOLUTELY NO** flexi-leads are permitted inside the building.

The building opens 6:30 AM.

MEASURING: There is NO VMO scheduled to be a VMO at this event. All measurements performed by the judge are only official for the weekend. **If you do NOT have a valid temporary or permanent height card, OR have one Permanent measurement by a VMO, you MUST be measured by the judge of record before running.** If you have received a valid temporary or permanent height card since sending in your entry (i.e. your confirmation still shows "measure"), please let me know so I may mark the database properly.

CRATING: Ample crating space will be available. Please use mats underneath all crates. Dogs with space or barking issues should **NOT** be crated near the agility field. Crates may be left overnight; however, VCA, Omaha Sports Complex and JPAWS Agility Trial Services will not be responsible for any lost or damaged items left at the show site. Dogs may NOT be left overnight

SITE INFORMATION: As always, clean up after your dog. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may be subject to AKC sanctions.

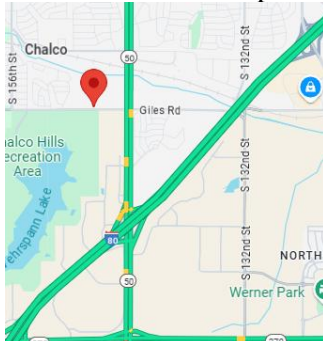
We will be using Agility Gate. No printed Gate Sheets will be used. If you have a smart phone, there are links below to download the app. You can check in or scratch your dog and review where we are in the running order by using the app. The code for the trial will be **68138** (the zip code of the site). Gate sheets will be loaded the evening before (Saturday's gate sheets will be loaded by Friday evening). 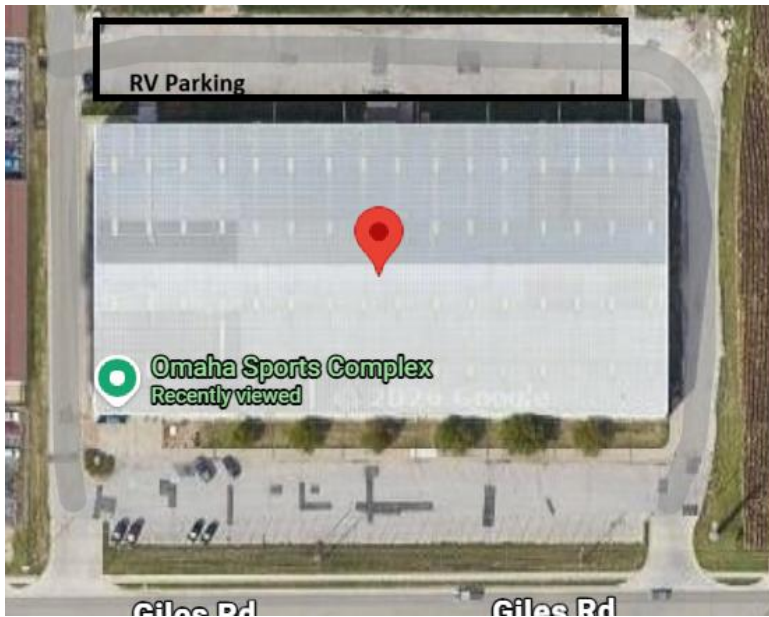
