This trial is being held at Rush 'N' Around Agility and Obedience Center, 27432 South Route 45 (LaGrange Rd), Manhattan, IL 60442. Food will not be available for purchase on site. There will be **no flexi-leads** inside the building. There is ample parking available

### **There will be condensed crating in the building.**

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. Building opens at 6:30AM both mornings

The judge will be the VMO at this event. If your dog has never been measured or has turned 2 since the last measurement, your dog will need to be measured before running. Please allow ample time for measuring
