There will be limited crating inside the building, **and no flexi-leads**. There is ample parking available

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. No Thursday setup. Building opens at 6:30 a.m. both Saturday and Sunday.

There will be a VMO at this event. The judge is also a Volunteer Measuring Official (VMO) for this event. Dogc will need to be measured before running. Please allow ample time for measuring.
