This trial is being held at Rush 'N' Around Agility and Obedience Center, 27432 South Route 45 (LaGrange Rd), Manhattan, IL 60442. Food will not be available on site. There will be VERY limited Crating inside the building, **and no flexi-leads**. There is ample parking available

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. No Thursday setup. Building opens at 6:30 a.m. all three days.

There is NO VMO at this event. If you do not have a Temporary or Permanent height card or have one measurement for your permanent height card, you will need to be measured by the judge before running. This measurement will be valid for the weekend only. PLEASE keep in mind her primary task is judging, allow ample time to be measured.

WORKERS: PLEASE consider signing up to work in advance of the event. Links to the worker signup will be posted on the JPAWS website before the trial.
