This trial is being held at Rush 'N' Around Agility and Obedience Center, 27432 South Route 45 (LaGrange Rd), Manhattan, IL 60442. Food will not be available for purchase on site. There will be **no flexi-leads** inside the building. There is ample parking available

NOTE START TIME: 8:30AM

There will be condensed crating in the building.

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. No Thursday setup. Building opens at 6:30 a.m. on Friday.

There is no VMO at this event. If your dog has never been measured or has turned 2 since the last measurement, your dog will need to be measured by the judge before running. This measurement will be valid for this weekend only. Please allow ample time for measuring.

WORKERS: PLEASE consider signing up to work in advance of the event. A link to the worker signup has been posted on the JPAWS website.

We will be using an app called Agility Gate for this event. **The code for this event is 60442** (the Zip code for Rush 'N' Around). You can use this app to check in, see the running order, who has run, etc. For more information, visit the website and watch the video relating to this app:
