Thank you for entering Paw Power Blues Agility Club of North West Indiana's November agility trial. This trial is being held at Rush 'N' Around Agility and Obedience Center, 27432 South Route 45 (LaGrange Rd), Manhattan, IL 60442. Food will not be available on site. There will be limited crating inside the building, **and no flexi-leads**. There is ample parking available.

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. No Friday setup. Building opens at 6:30 a.m. both Saturday and Sunday.

Walk thrus will be split at the discretion of the judge.

There is no VMO scheduled to be at this event. Dogs needing to be measured must be measured by the judge before running and will be valid for this weekend only.

WORKERS: PLEASE consider signing up to work in advance of the event. A link to the worker sign up has been posted on the JPAWS website.

We will be using an app called Agility Gate for this event. **The code for this event is 60442** (the Zip code for Rush 'N' Around). You can use this app to check in, see the running order, who has run, etc. For more information, visit the website and watch the video relating to this app:

Course maps will be posted in the building and online by 6:00AM (for that day) on the JPAWS Website. Remember, JPAWS has two trials that weekend. Make sure you are looking at the correct maps. **NO EXHIBITOR COPIES WILL BE PROVIDED.**

From I-294 or I94, Exit at I-57 south. Continue south to exit 355 to Manhattan-Monee Road. Continue West on Manhattan-Monee Road to Route 45. Turn Left (south) on route 45 for about 2.5 miles to the trial site.
