Thank you for entering the Paw Power Blues Agility Club of NW Indiana's October agility trial. This trial is being held at Pawsitively Heaven Pet Resort, 10051 Kitty Ave, Chicago Ridge, IL 60415. Food will not be available on site, but there are plenty of fast food options nearby. NO flexi-leads are permitted inside the building.

NOTE: The building opens **7:00 AM** both days.

MEASURING: There is NO VMO scheduled to be at this event. Any unmeasured dogs will need to be measured by the judge. If your measurement changes the jump height you are entered in, please come see the secretary to discuss your options.

The site will NOT be available for general exhibitor set up on Friday.

PARKING is NOT available in the grassy lot across from Pawsitively Heaven. Parking is permitted in the paved lot by Lexington Nursing Home. Parking is also permitted at the Chicago Ridge Municipal Parking lot and the Fire Department parking lot (PLEASE do not block doors). Parking spots near the building will be reserved for people working from their vehicles. If you park there and are crating inside, you will be asked to move. If you fail to do so, you could be asked to leave the event without a refund.

WORKERS: PLEASE consider signing up to work in advance of the event. A link to the worker signup will be posted on the JPAWS website by Thursday at 8:00PM. Lunch and snacks will be available for workers.

We will be using Agility Gate for this event. The code for the weekend is **60415** (the Zip Code). You can use this app to check in, see the running order, who has run, etc. For more information, visit the website and watch the video relating to this app:

Once the judge signs off on results, official results will be placed in a binder with the ribbon labels. **PLEASE do NOT rip the ribbon label sheets**

Course maps will be posted in the building and on our website after 6:00AM (on the day of the event). Saturday's courses will be posted on Saturday morning by 6:00AM. **NO EXHIBITOR COPIES WILL BE PROVIDED.**

DIRECTIONS:

From the north: Take I-294 South to 95th Street (also Rts 12/20) and exit east. Stay to the right and take the ramp to Harlem Road south (second ramp, first will put you back onto I-294 north). At the first light turn left onto 99th Street. Go to the stop sign and turn right onto Sayre Avenue. Turn left at the next stop sign onto Virginia Avenue. Turn right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.

From the south: Take I-294 North to 95th Street (also Rts. 12/20) and exit east. Stay in the right lane and take the ramp to Harlem Road south. At the first light turn left onto 99th Street. Go to the stop sign and turn right onto Sayre Avenue. Turn left at the next stop sign onto Virginia Avenue. Turn right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.
