Thank you for entering the Siberian Husky Club of Greater Chicago/ Siberian Husky Club of America agility trial. This trial is being held at CarDunAl Obedience Training Club, 10783 Wolf Drive, Huntley, IL 60142. The training center is in the southwest corner of the second building on the right. **There will be no barking dogs allowed in vehicles, they must be crated inside.** Fast food restaurants are nearby. Any additional questions regarding the site and its amenities should be directed to the trial chairperson.

IMPORTANT: TO ALL EXHIBITORS – PLEASE READ CAREFULLY. In order for CarDunAl to be able to keep renting this facility please adhere to these rules. Please note that the building will NOT OPEN TILL 6:45 AM. **DO NOT COME ANY EARLIER THAN 6:45 AM!** We know that some of your dogs are very exuberant and can't help but bark. For those that are not able to prevent your dogs from barking, YOU MUST park in between the buildings so our neighbors in homes to the west aren't disturbed.

Protective matting is required under all wire dog crates and chairs to protect green flooring. Do not walk your dogs along the fence on the west side of the drainage area. Walk dogs on the east side of the drainage area and along the south side of the buildings.

NO PARKING IS PERMITTED in parking spots directly in front of the gymnastic club next to us.

MEASURING. There will be a Volunteer Measuring Official (VMO) in attendance at this event and the Judge can act as VMO if a second measurement is needed. **If you do NOT have a valid temporary or permanent height card, you MUST be measured by the VMO.** If you require a second measurement, the judge, also a VMO, can do this measurement when convenient. If you have received a valid temporary or permanent height card since sending in your entry (i.e. your confirmation still shows "measure"), please let me know so I may mark the database properly. PLEASE ensure ample time to be measured before your run.

We will be using Agility Gate. No printed Gate Sheets will be used. If you have a smart phone, there are links below to download the app. You can check in or scratch your dog and review where we are in the running order by using the app. The code for the trial will be **60142** (the zip code of the site). Gate sheets will be loaded the evening before (Friday's gate sheets will be loaded by Thursday evening). We will be using a display monitor for preliminary (unofficial) results. Official results will be posted in a binder with ribbon labels once the judge has signed off on results.

No printed copies of course maps will be provided. Maps will be posted in the building and will be available online by 6:00AM on the day of the event (pending no issues receiving the maps from the judge).

Directions to the site are as follows:

From the east, take I-90 to the Route 47 exit. Go north on Route 47 approximately 3.7 miles to Oakcrest Drive and turn left (known as Algonquin Road to the right). Go less than .1 mile on Oakcrest to Wolf Drive and turn left.

From the west, take I-90 to the Route 20 exit. Go west (left) 1.6 miles to Harmony Road. Turn right on Harmony Road and drive 3.7 miles to the stop sign, then turn left to stay on Harmony Road. Drive to the next stop sign and turn right (Main Street). Drive 1.4 miles on Main Street to Route 47 and turn left. Go 0.4 miles north on Route 47 to Oakcrest Drive and turn left. (Algonquin Road to the right). Drive approximately 0.1 miles to Wolf Drive and turn left
