This trial is being held at Rush 'N' Around Agility and Obedience Center, 27432 South Route 45 (LaGrange Rd), Manhattan, IL 60442. Food will not be available for purchase on site. There will be **no flexi-leads** inside the building. There is ample parking available

**There will be minimal crating in the building. PLEASE consider crating out of your vehicle.**

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. No Thursday setup. Building opens at 6:30 a.m. on Friday.

There will be a VMO at this event. The judge is also a Volunteer Measuring Official (VMO). Dog will need to be measured before running. Please allow ample time for measuring.

We will be using an app called Agility Gate for this event. **The code for this event is 60442** (the Zip code for Rush 'N' Around). You can use this app to check in, see the running order, who has run, etc. For more information, visit the website and watch the video relating to this app:

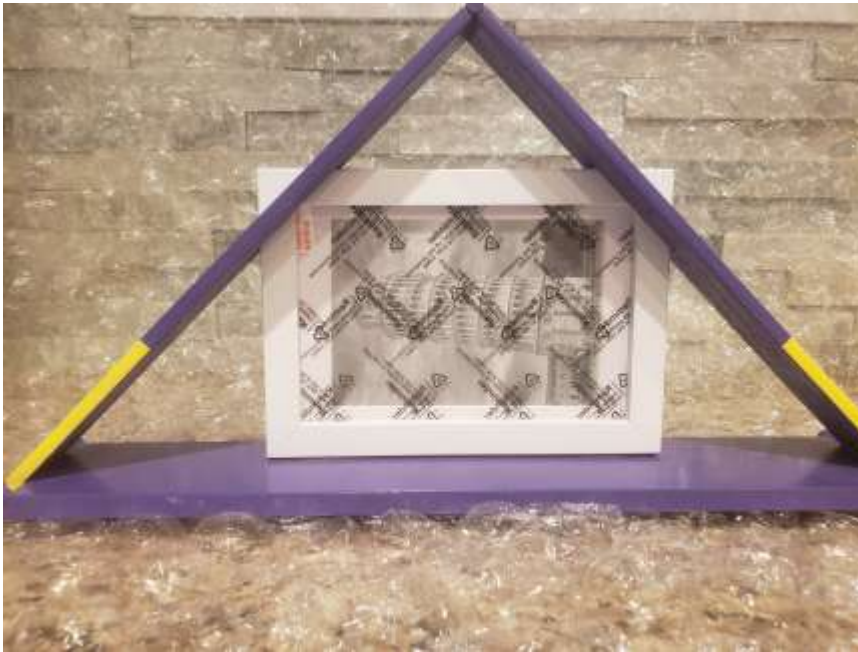
