## AKC Agility Trial

June 12, 2026



Thank you for entering the Winnebago Labrador Retriever Club's agility trial. This trial is being held at the Forest City Dog Training Club 6203 Material Avenue, Loves Park, IL 61111. Food will not be available on site, but there are plenty of fast food options nearby. **NO** flexi-leads are permitted inside the building.

The building opens 6:45AM.

**MEASURING:** The judge will be the Volunteer Measuring Official (VMO) for this event. PLEASE allow extra time before your run to ensure you get measured. Once measured, come to the score table so I can update your height in my database. **If you run and are not measured the AKC will remove any legs you may have earned this weekend.** If you have received a valid temporary or permanent height card since sending in your entry (i.e. your confirmation still shows "measure"), please let me know so I may mark the database properly.

**No printed course maps will be provided.** Course Maps will be posted in the building and will be posted online on my website by 6:00AM each day.

We will be using the app Agility Gate for this event. The code for the weekend is **61111** (the Zip Code). You can use this app to check in, see the running order, who has run, etc. For more information, visit the website and watch the video relating to this app:

**CRATING:** Mats are required to be placed under your crates. Please try to conserve space as much as possible. Dogs with space issues must be covered and non-disruptive.

**WORKERS:** Worker signup link is on the JPAWS website. Please consider working to help the trial run smoothly. The worker signup links will be active until Thursday, June 13 at 8:00AM. Any changes to worker signup after that time should be made at the trial.

**SITE INFORMATION:** As always, clean up after your dog. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may be subject to AKC sanctions. Please adhere to the posted signs as to where to exercise your dogs as this has also changed.

### Directions to the site are as follows:

**From I90/39: Take the E. Riverside Blvd exit.** Turn west onto E. Riverside Blvd towards town. Turn right onto Material Ave. Forest City Dog Training is in the brown industrial park on the right side of the road.
