## AKC Agility Trial

Thank you for entering Greater DeKalb Kennel Club agility trial. This trial is being held at CarDunAI Obedience Training Club, 10783 Wolf Drive, Huntley, IL 60142. The training center is in the southwest corner of the second building on the right. **There will be no barking dogs allowed in vehicles, they must be crated inside.** Fast food restaurants are nearby. Any additional questions regarding the site and its amenities should be directed to the trial chairperson.

**IMPORTANT: TO ALL EXHIBITORS – PLEASE READ CAREFULLY. In order for CarDunAI to be able to keep renting this facility please adhere to these rules.** Please note that the building will NOT OPEN TILL 6:45 AM. **DO NOT COME ANY EARLIER THAN 6:45 AM!** We know that some of your dogs are very exuberant and can't help but bark. For those that are not able to prevent your dogs from barking, YOU MUST park in between the buildings so our neighbors in homes to the west aren't disturbed.

**Protective matting is required under all wire dogs crates and chairs to protect green flooring.** Do not walk your dogs along the fence on the west side of the drainage area. Walk dogs on the east side of the drainage area and along the south side of the buildings. There will be NO Thursday night set up.

**NO PARKING IS PERMITTED** in parking spots directly in front of the gymnastic club next to us.

We will be using Agility Gate. No printed Gate Sheets will be used. If you have a smart phone, there are links below to download the app. You can check in or scratch your dog and review where we are in the running order by using the app. The code for the trial will be **60142** (the zip code of the site). Gate sheets will be loaded the evening before (So Friday's gate sheets will be loaded by Thursday evening). We will be using a display monitor to show preliminary (unofficial) scores. Official results will be posted in a binder after the judge has signed off on them. PLEASE do not congregate around the display or binder. If you have a smart phone, take a picture and move along to allow someone else to do the same.

If you did request a measurement, you will need to have your dog measured. There will be a Measuring Official (VMO) at this event. PLEASE Allow time to get your dog measured before you run. If you run and are not measured the AKC will remove any legs you may have earned this weekend.

#### **Directions to the site are as follows:**

**From the east**, take I-90 to the Route 47 exit. Go north on Route 47 approximately 3.7 miles to Oakcrest Drive and turn left (known as Algonquin Road to the right). Go less than .1 miles on Oakcrest to Wolf Drive and turn left.

**From the west**, take I-90 to the Route 20 exit. Go west (left) 1.6 miles to Harmony Road. Turn right on Harmony Road and drive 3.7 miles to the stop sign, then turn left to stay on Harmony Road. Drive to the next stop sign and turn right (Main Street). Drive 1.4 miles on Main Street to Route 47 and turn left. Go 0.4 miles north on Route 47 to Oakcrest Drive and turn left. (Algonquin Road to the right). Drive approximately 0.1 miles to Wolf Drive and turn left
